
This document should be needed only once, either to set up your Single Login Profile (SLP) or to relink your account to your default court. Once you have completed the steps below, you will be able to log in to your eVoucher account using your email address and password, and link to your other court accounts. Please review the **Signing In to eVoucher and Modifying Your SLP** document to learn how to log in to eVoucher after you've created your Single Login Profile (SLP).

# Accessing the CJA eVoucher Program

Prior to version 6.4, if you had eVoucher accounts in multiple courts, you were required to log out and log in to each individual court account you wanted to work in. You had a separate username and password assigned by each individual court. Starting with version 6.4, you can now create a Single Login Profile (SLP) with a single email address and password that can be linked to each eVoucher account you have. You can now switch from one eVoucher account to another from within the eVoucher application without the need to log out.

**Note**: Users with more than one eVoucher account must designate one account as the default account—the court used to create your Single Login Profile (SLP) automatically becomes your default court, unless you change it.



### Single Login Profile for David D. Attorney

The email address used to create your Single Login Profile (SLP) must belong to the person accessing eVoucher and must be unique. Your email address will be the only way to access eVoucher.

#### Step 1



- Answers must contain between 3 and 60 characters.
- Special characters are not allowed in answers.
- Answers containing all spaces are not allowed.
- Answers must not contain leading or trailing spaces.
- Answers must not contain more than one consecutive space between words.

# Step 5

The system generates a message asking you to check your email. The email message goes to the email address you provided when creating your Single Login Profile (SLP).



Note: The link provided in the email is valid for only 30 minutes and can be used only once.

# Step 7

In the **Enter password** field, enter a new password that you will use for your Single Login Profile (SLP). To meet password requirements, the new password must:

- Contain at least eight (8) characters.
- Be alphanumeric.
- Contain at least one lowercase and one uppercase character.
- Contain at least one special character.
- Not be a password used within the past 365 days.




To view current password requirements, click the **Password Requirements** (+) icon. You are required to change your password every 180 days. In the **Verify password** field, reenter the password, and then click **Next**.
