THIS FORM IS TO BE USED BY ATTORNEYS WHO PREVIOUSLY SERVED OR WHO CURRENTLY ARE SERVING ON THE CJA PANEL FOR THE NORTHERN DISTRICT OF GEORGIA AND SEEK TO SERVE FOR THREE (3) YEARS, PURSUANT TO THE RENEWAL PROVISIONS IN THE CJA PLAN.

Attorneys who seek to reapply for placement on the CJA Panel must be members in good standing of the State Bar of Georgia and admitted to the Bar of the Northern District of Georgia and have demonstrated experience in, and knowledge of, the Federal Rules of Criminal Procedure, the Federal Rules of Evidence, the Sentencing Guidelines, the Bail Reform Act, and the local criminal procedures for the Northern District of Georgia.

As provided for in the Criminal Justice Act Plan for the Northern District (Appendix D to the Local Rules -- please review), applications to reapply for placement on the CJA Panel are due every THREE (3) years and will be submitted to the CJA Panel Committee. **APPLICATIONS FOR REAPPOINTMENT ARE DUE BY SEPTEMBER 30 OF THE PANEL MEMBER'S FINAL YEAR OF THEIR CURRENT APPOINTMENT TERM.**
