PRACTICE AND PROCEDURE ORDER NO. 28

(Order to Show Cause for Non-Responsive Plaintiffs)

Plaintiffs' Leadership reached an agreement to resolve certain pending actions in this MDL 2872 effective September 7, 2021. Since that time the Court has continued to monitor the progress of the resolution of cases including requesting and receiving information from MDL leadership regarding the settlement. The Court is aware that all cases identified on Exhibit A, attached hereto, received an offer to resolve their case on April 27, 2022. When the Court inquired as to the current status of the cases on Exhibit A, it was informed that on September 1, 2022, Plaintiffs' Leadership contacted all plaintiffs' counsel for cases on Exhibit A to ascertain the intent of plaintiffs because no release had been delivered in acceptance of the settlement offer. Plaintiffs' Leadership has informed the Court that despite diligent

effort on the part of counsel, the clients listed on Exhibit A could not be located. The Court, at its request, has also been informed that Plaintiffs' Leadership provided further notice to each firm on Exhibit A on October 13, 2022, requesting that counsel for each plaintiff locate their client and deliver a release for those previously unlocated clients on or before October 28, 2022. As of the date of this Order, Plaintiffs' Leadership reports to the Court that there remain 38 cases on Exhibit A where plaintiffs' counsel reports that, to date, the client cannot be located.

Based on the foregoing and in an effort to manage this docket, IT IS HEREBY ORDERED that all cases on Exhibit A attached hereto must show good cause why their case should not be dismissed for failure to prosecute on or before November 18, 2022, by either: (1) filing a statement explaining why the case should proceed on the individual case docket with a copy delivered to Plaintiffs' Leadership via email to physiomesh@bbga.com; or (2) delivering a completed release using the Archer release database established by Plaintiffs' Leadership. If no action is taken by counsel for those plaintiffs on Exhibit A, or if good cause is not shown, the Court will consider dismissing cases where the plaintiff cannot be located based on the failure to prosecute the case

This Order shall be entered on the docket in each individual case shown on Exhibit A.
